Dear Mr. Systrom:

I write to ask that Instagram prohibit the use of its service to enable sales of firearms, consistent with policies adopted by online marketplace entities such as Craigslist and eBay. According to a recent story in *The Daily Beast*, a growing number of Instagram's users are conducting unregulated gun sales through Instagram's widespread mobile and Internet application. I am concerned that such sales may circumvent or violate various state and federal laws and that, as a result, a significant number of unlawful sales of firearms may be occurring through Instagram's mobile and online service.

Unlike online marketplaces such as eBay, Instagram's technology enables a seller to publicize products widely without registering as a seller or otherwise disclosing his or her identity. Firearms sales that are initiated via Instagram can be concluded offline, in the absence of any statutory or regulatory requirements. As a result, it is possible that some could be occurring to those under eighteen years old, to out of state buyers by sellers in states that have prohibitions on interstate sales of firearms, or by sellers who are declining to conduct background checks – despite residing in states where such background checks are required.

Instagram's application offers an array of ever-expanding search terms that enable users to explore a vast universe of firearms available for purchase, such as #gunsforsale, #gunstore, #guns_of_instagram, #AR15, and #AK47. Once the user has identified the desired firearm, sales can be easily negotiated and completed offline.

Other companies that enable online sales have enacted commonsense protocols to prevent widespread weapons trading on their systems. eBay, for instance, prohibits the sale of actual firearms on its site.² Craigslist forbids both the sale and advertisement of all "weapons and related items, including firearms, ammunition, silencers, pellet/BB guns, tear gas, or stun guns." Facebook, Instagram's parent company, states that,

Ads and Sponsored Stories may not promote firearms, ammunition, paintball guns, bb guns, fireworks, explosives, pepper spray, knives, tasers, or weapons of any kind, including those used for self-defense. Ads and Sponsored Stories may not directly or indirectly link to landing pages where users can purchase any of these products. ⁴

I encourage Instagram to take similar steps and adopt safe business practices that curb the marketing and sale of guns through Instagram. Thank you for your attention to this important matter.
