T'ruah: the Rabbinic Call for Human Rights

"Solitary confinement is torture, and it is predominantly inflicted on Black and Brown people. Solitary causes immense suffering and devastating harm, and has taken far too many minds and lives, including Kalief Browder, Layleen Polanco, Brandon Rodriguez, and countless others.
