Dear President Trump, Leader Thune, and Speaker Johnson,

In May, Republicans in the U.S. House of Representatives passed a reconciliation package that, if enacted, will impose the largest cuts to health care in United States history, slashing funding for Medicaid and the Affordable Care Act by more than \$1 trillion and triggering more than \$500 billion in Medicare cuts. Republicans' cuts to Medicaid and the Affordable Care Act will cause 16 million people in the U.S. to lose health insurance coverage. A majority of adults living in rural areas are concerned that these health care cuts will "negatively impact hospitals, nursing homes, and other health care providers in [their] community."¹ They are right to be worried, as these cuts will have devastating consequences for health outcomes and costs, jobs, and the economic success of rural communities. Today, we write to provide you with detailed information about rural hospitals that are uniquely at risk of financial distress and even closure, conversion, or service reductions because of the cuts in the House-passed reconciliation package. The information provided by the Cecil G. Sheps Center for Health Services Research at the University of North Carolina (Sheps Center) illustrates what your party's reconciliation bill will mean for the health of Americans living in rural communities.

Enacting these drastic health care cuts that will kick millions of people off their health insurance coverage, rural hospitals will not get paid for the services they are required by law to provide to patients. In turn, rural hospitals will face deeper financial strain that could lead to negative health outcomes for the communities they serve. Already, rural hospitals are struggling: in 2023, there were 50 fewer rural hospitals than in 2017, and lack of health care access in rural America is contributing to worse health outcomes.² Faced with additional cuts to their revenue, many rural hospitals may be forced to stop providing certain services, including obstetric, mental

health, and emergency room care, may have to convert to clinics or standalone emergency centers, or close altogether. Rural hospitals are often the largest employers in rural communities, and when a rural hospital closes or scales back its services, communities are not only forced to grapple with losing access to health care, but also with job loss and the resulting financial insecurity.³

In order to understand in greater detail how rural communities could be impacted by health care cuts contained in the reconciliation package, we requested the attached data from the Sheps Center on the financial vulnerability of rural hospitals and potential impacts on their viability.⁴ These hospitals have been identified as at-risk hospitals based on financial data, including: whether the hospital has been unprofitable for the last three years; whether the hospital is at risk of financial distress relative to peer hospitals; and whether the hospital serves a disproportionately high share of Medicaid patients. The findings demonstrate that hundreds of rural hospitals across the country would feel pain from the House-passed reconciliation bill. Altogether, 338 hospitals either experienced three consecutive years of negative total margins, serve the highest share of Medicaid patients or both.⁵ 83 rural hospitals are at the highest relative risk of financial distress based on a model that uses hospital financial performance, organizational traits, and market characteristics to predict future financial distress.⁶

Republican health care cuts would be felt by rural hospitals across the country. In Louisiana, 32 rural hospitals—or a majority of rural hospitals in the state—are serving a high concentration of Medicaid patients. A total of 33 hospitals are at risk based on serving a high share of Medicaid patients, experiencing negative total margins, or both. In Alaska and Kentucky, 44 percent of the rural hospitals with available Medicaid payer mix data serve high concentrations of Medicaid patients. In West Virginia, nearly a quarter of rural hospitals are serving high concentrations of Medicaid patients, and 15 percent of rural hospitals are at the highest relative risk of financial distress, per the financial distress index. In Alabama, 8 rural hospitals—nearly 20 percent of rural hospitals with available data—are in the highest relative risk category of financial distress. In Tennessee, 9 rural hospitals—or 18 percent of rural hospitals in the state with available data—have experienced 3 years of negative total margins, and 9 rural hospitals are at highest relative risk of financial distress. In short, many of these rural




hospitals are facing financial instability today, even before any of the Republican health care cuts take effect. Rural hospitals will be disproportionately impacted by health care cuts.

Addressing the crisis in rural health care access is a national, bipartisan priority,⁷ and it should be bipartisan to not worsen it. However, if your party passes these health care cuts into law, Americans in rural communities across the country risk losing health care services and jobs supported by their local hospitals. We urge you to read the attached report and reconsider your position. It is not too late to stop these cuts. Billionaire tax breaks are not worth the cost to American lives and livelihoods.
